Challenges in an extraordinary year

In January 2020, all stakeholders in the field of nationality law started their work preparing for a normal year, but two months later, everyday life was about protecting against a pandemic and safeguarding our communities.


The activities of nationality advocacy bodies have been quickly and completely transformed by the **shrinking opportunities** for face-to-face meetings, the challenges of online communication and the economic and financial difficulties faced by institutions and individuals alike.



Despite these challenges, the Minority Ombudsman has carried out an intensive professional activity, examining 351 individual complaints, initiating 20 ex-officio procedures and issuing 12 key professional documents.

MAIN INTERNATIONAL **EVENTS**



The staff member of the Minority Ombudsman's Secretariat participated

in the online discussions of the Equinet **Policy Formation** Working Group, where the main topics were:

The topics of the online forum included the situation and challenges of minority protection in Europe, Hungary and Romania, the enforceability of international documents, the Minority SafePack, the situation of language rights, the current of the nationality state institutional system in the two countries and the possibilities for further steps. The Minority Ombudsman delivered a presentation at the FUEN (Federal Union of European Nationalities) onconference "Minority protection and the rights of ethnic groups in Central and Central-Eastern Europe" on 25 March, which focused on the protection of minorities in Hungary, Croatia and Slovakia and the specificities of the application of the law in each country.

PROVISION OF INFORMATION TO INTERNATIONAL **ORGANISATIONS**

In the first quarter of 2021, the Minority Ombudsman provided information several on occasions to international organisations dealing with the rule of law. human rights and ombudsman institution in **Hungary:**

- Universal **Periodic Review** (UPR) of the human rights situation in Hungary,
- Review Process of "A" status of the Commissioner for Fundamental Rights, carried out by the Global Association of National Human **Rights** Institutions (GANHRI), Subcommittee on Accreditation,
- Preparation of the Annual Rule of Law Report coordinated the by European Network of National **Human Rights Institutions** (ENNHRI).



The president of a national minority self-government complained that during the pandemic emergency, the mayor, exercising the competence of the authority of the representative body, had adopted amendment to the body's Organisational and Operative Regulations, abolishing the previously autonomous nationality committee.

connection with the performance of public purpose work, the complainant indicated that he had not been allowed to sign the attendance sheet, without which he could not certify the performance of the work. He complained also that he had not been provided with adequate protective clothing.

In an individual complaint from a town in Eastern Hungary, the petitioner complained that he and 17 other residents had been moved from one segregated part of the town to another one in the framework of an EU-funded segregated settlement rehabilitation project.

A nationality self-government complained about the postal service's behaviour. According to the complaint, a private individual wanted to pay the next year's fees for a weekly newspaper of the nationality community he belonged to, when the employee of the post office handled the payment documents separately, **asked for the payer's personal identification details and recorded them** in the computerised register. The self-government complained that questions about the recording of data and the procedure were not answered by the administrator.

The head of a kindergarten submitted an application to the competent municipality as the maintaining authority, claiming that the legal representatives of the children in the kindergarten had taken an initiative to organise bilingual kindergarten **education** for the next year. In view of the emergency situation declared by the Government, the maintaining authority did not take a decision on the reorganisation of the kindergarten.

A petitioner of Roma nationality complained the about measures taken against him in a priority level penal institution, in particular the handcuffing, humiliation, abuse and treatment. He complained that he had spent nearly two hours in the winter in his underwear cold with socks and the window the open in detention facility.
