In addition to the above, the investigation of individual complaints and the overall irregularities detected on the basis of these complaints and ex officio is ongoing.

Professional cooperation in the preparation of the comprehensive amendment of the Act on the Rights of the Nationalities

On 15 June, the Parliament adopted Act XCVII of 2021 amending the Act on the Rights of the Nationalities (Njtv.).

The Minority Ombudsman was involved in the drafting of the legislative text, which took nearly two months, and shared her professional views in writing and orally with the leaders of the NEB and the ONÖSZ on several occasions.

The amendments mainly define the rules for setting nationality election lists and the possibilities for legal remedies.

## MAIN DOMESTIC EVENTS

## On-site investigation in Gyöngyöspata

Between 31 May and 1 June, the Minority Ombudsman and her staff conducted an onsite inspection in Gyöngyöspata, where they met personally with local kindergarten and primary school children, and held professional discussions with the heads and staff of the educational institutions operating in the settlement, the mayor of the settlement, the president of the Roma nationality self-government and the director of the Hatvan School District Centre.

#### **ADOPTING THE REPORT FOR THE YEAR 2020**

On 11 May 2021, the **Parliament's Committee of the Nationalities in Hungary** (NEB) discussed the report of the Commissioner for Fundamental Rights and his deputies on the activities of the year 2020, submitted to the Parliament under number B/15278. The body unanimously adopted the document, while expressing its appreciation for the rights protection activities in the field of national minority rights in 2020.

The Ombudsman reported on his activities in 2020 with his deputies at the **plenary session of the Parliament on 8 June 2021**, after the committee debates had been concluded. The NEB's position was presented by Romanian nationality advocate Traján Kreszta during the debate on the document. <u>Details here</u>.

## A new community space opened in Pécs for the nationality self-governments and nationality culture

The Minority Ombudsman attended the opening ceremony of the **Office of Nationality Self-governments and Civil Organisations in Pécs**. The office was established with the aim of providing appropriate environment for the operation of the nationality self-governments and civil organisations in Pécs. After the opening ceremony, she held a personal meeting with the Mayor of Pécs.

Since the beginning of her mandate, the Minority Ombudsman has been following closely the efforts of cities with rich and living national minority traditions to protect their local communities and develop their national minority culture. Details here.

## Police measures taken in the context of increased control

One Roma petitioner complained about the **specific police measures** taken against him (stop, search of his clothing, check of his mobile phone) and also expressed concerns about the increased control on which the measure was based. He also objected to the fact that his personal data were recorded despite the fact that no further action followed the stop.

The joint report on the case concluded that the decisions of the national police captain ordering a nationwide increased control on the basis of which the complainant was stopped and his clothing searched violated the principle of legal certainty, both in form and in substance.



In view of this, it has been **proposed** that the Minister of the Interior should consider reviewing the rules on increased control and initiate a change in the regulations.

The national police captain was also **requested** to review the practice of ordering increased controls.

## Breach of the obligation of cooperation

The presidents of the Roma nationality self-governments of Nógrád County submitted a joint petition to the Minority Ombudsman concerning the closing of the main entrance to a cemetery and the prohibition of access by car. The Minority Ombudsman also learned from social media about serious problems of cooperation between the Roma nationality self-government and the municipal self-government of the settlement

in question.

The Commissioner and the Minority Ombudsman opened an investigation into the matter. In the course of their investigation, they contacted the mayor of the municipality, the president of the Roma nationality self-government concerned and asked the head of the relevant district office to conduct an investigation. Despite repeated notices, the local government failed to respond to the official requests, therefore a joint report was issued, stating that there had been a breach of legal

certainty and calling on it to comply with its obligations by taking immediate action.

They also **called on** the Government Commissioner to use the means at his disposal to ensure that future requests from the Commissioner and his deputies are fully complied with in a timely manner by the local authorities under investigation and by all local authorities in the county.

## General Comment 1/2021 on the specific and systemic shortcomings of the educational and child protection systems

The Minority Ombudsman issued her general comment on the basis of an investigation of a specific complaint, aiming to draw attention to the developmental difficulties, educational and integration problems of a Roma pupil with BMD difficulties, the serious conflicts between parents and teachers, and to highlight systemic problems.

The investigation concluded that the primary schools concerned, despite their formal due process, did not do everything possible to ensure the proper development of the pupil with integration, learning and behaviour difficulties, and their failure to do so violated the principle of best interests of the child.

The **proposals for amendments** to the relevant law and EMMI regulations sent by the Minority Ombudsman to the Secretary of State for Public Education for consideration were adopted.

The proposed amendments could



facilitate and improve the flow of information on the progress ofchildren, pupils with special educational needs and those with difficulties in integration, learning and behaviour.

## General Comment 2/2021 on the current situation of the accessibility of nationality public service radio broadcasts

As a follow-up to the Minority Ombudsman's General Comment 3/2018, and in view of the discontinuation of digital radio broadcasting in September 2020, **she reviewed the current situation of the accessibility of public service nationality radio programmes**. In her general comment, which concluded a comprehensive investigation, the Minority Ombudsman **recommended** that, in order to achieve accessibility equivalent to that of radio broadcasts for the majority of the population, the management of the public service media should take steps to substantially improve the technical conditions and reception opportunities for public service nationality radio broadcasts on the terrestrial platform, on the basis of a strategy to be developed together with the elected representatives of the nationalities.

procedures, in particular the issuing of official certificates.

She has not identified any structural problems in the course of the investigation, nevertheless she made professional recommendations, in particular in the areas of promoting the legal awareness of persons belonging to a nationality and of officials involved in the registration of births, partial amendments to the rules on registration

in nationality languages and the online availability of nationality surname registers.

The Minority Ombudsman also called for closer cooperation between the NEB, the ONÖSZ and the Minister of the Prime Minister's Office.

The aim of the training was to improve the protection of people who suffer discrimination and to promote equal and universal access to health care. Details here.




## "Nation, Community, Minority, Identity: the role and the activism of national constitutional courts in the protection of constitutional identity"

The Minority Ombudsman was informed ex officio about a **stone wall** built near a densely Roma-populated part of a village in eastern Hungary, which had been built to close off almost an entire section of a road, **on top of which the owner had recently installed electricity.**

In a town in Eastern Hungary, during the implementation of a project aimed at the rehabilitation of run-down urban areas. the local government called on several Roma families to leave their rented social housing owned by the municipality, which was being renovated as part of the project, but no other housing or accommodation was provided or guaranteed for them.

A complainant of Roma nationality referred a **housing case** to the Minority Ombudsman. In his complaint, he indicated that he had been applying to the municipality for housing for several years without success. Together with his partner, the complainant has two minor children with whom he currently lives in a small room with his parents. He also complained that his family had not received the **aid package donated by the national government** during the emergency.

# CASE LAW MOSAIC

On the occasion of the **10**<sup>th</sup> anniversary of the Network of Christian Colleges for Advanced Studies for the Roma (KRSZH), the Minority Ombudsman welcomed the achievements of the colleges and the movement, and offered further professional and partnership cooperation to the heads of the institutions.

The Minority Ombudsman, while continuously monitoring the impact of the pandemic on national minorities, in particular the community, Roma and following reports from NGOs, became aware of a local mass coronavirus infection in a settlement in Eastern Hungary, mainly affecting Roma.

In the light of the circumstances of the case, she immediately contacted the mayor of the settlement and the Deputy State Secretary for Social Inclusion.

The head of an international Roma rights NGO complained in a petition that a political party and two far-right organisations are organising a marching rally in a Pest county municipality under the slogan "Enough of Gypsy Crime!". The Minority Ombudsman ordered an investigation and, as a professional observer, also visited the demonstration to learn about the circumstances.
